## Environmental Impact Statement

Specialist studies have now been undertaken to assess the potential impacts of the Bomen Solar Farm. These studies have been compiled into an Environmental Impact Statement (EIS) which was submitted to the NSW Department of Planning and Environment (DPE) as part of the project's development application.

### Opportunities for Local Contractors and Service Providers


